AFTH Holiday Donation Aides 68 Children and 32 Mothers

AFTH Donated Over \$11,000 in Gift Cards this December

Each year just before the holiday season, AFTH identifies birthmothers who are parenting other children at home who are in need of a little additional financial assistance to get through the holiday season. This year, AFTH social workers identified 68 children and their mothers to be recipients of gift cards. AFTH's donation of gift cards helps birthmothers to purchase groceries, clothing and toys for their children during the holidays.

Thank you to AFTH supporters who helped by making a gift card donation. We received \$1,395 in gift card donations from AFTH clients and supporters to help bring cheer to families in need this holiday season. AFTH was overwhelmed by the response of donations as we saw more than double the gift card donations that we received last year. Your donated gift cards went directly into the hands of birthmothers who had need of them most, so thank you again for your generosity.

Each year after mailing out the gift cards, we hear back from many of the birthparents we have been able to help out with the donations. Here are a few of their thank yous we wanted to pass along to you:

Ali, a 16 year old birthmother from Western PA, hugged her mother and cried tears of joy when she was presented with the gift card donation. She said that AFTH gave her a Christmas they wouldn't have otherwise had because they didn't have any money.

Carrie, a birthmother from Central PA called her social worker to thank AFTH for thinking of her and her 4 children as she was able to give them a nice holiday thanks to the gift cards that were donated.

Tiffany, a New Jersey birthmother, called to thank AFTH for the donation. She received the gift cards at a perfect time as she was displaced because of hurricane Sandy and was just placed in a new apartment.

Penny in our Connecticut Office received this text from Diane: "Miss Penny. God bless you and your organization. Thank you soooooo much. God gave me an angel when he put you in my life. May God bless you multiple the blessing you are to me. Thank you."

Here are some more thank yous the agency received showing how a little bit of financial help to mothers during the holiday season can make all the difference.

Dionne, a birthmother who worked with our Pittsburgh Office, has two toddlers she is parenting and said she was so grateful for the wonderful Christmas gift from AFTH. Because of it she was able to buy toys for her children for Christmas that she could not have bought without the gift from the agency. She said how thankful she was that AFTH thinks of their birthmoms long after they have placed their babies.

Trisha of Western PA told Joan in our Pittsburgh Office she was like a Godmother to her because Joan somehow knew that she desperately needed money to have a Christmas for her 2 young children. Her ex-husband no longer pays child support and she had no other family to help her. She said that "head of our agency must be an angel because she really gives to those that need it."

Kim, a social worker in our Virginia Office called Crystal to let her know to be expecting the gift cards. She doesn't live in a safe neighborhood and Kim wanted her to keep her eyes out for the card. Crystal, who had placed two children through AFTH, thanked her over the phone and began to cry as she told Kim how she appreciates everything AFTH has done for her. Since Kim meet Crystal in 2008, her life has been pure turmoil. After a divorce which included a 2 year struggle for custody of her children, her boyfriend of several years was in a severe accident. Clayton, the birthfather of the two placed children, has been through several surgeries just to regain his ability to walk. Even with the surgeries, he is unable to work and has not been approved for disability. With Clayton and her three boys all being dependant on her, Crystal is working very hard to provide for their needs and keep their home. Kim reached out to her in December only to find out that three days earlier Crystal was diagnosed with cervical cancer that spread. She will soon be going through an extensive procedure to locate and treat all of the cancer and being the optimist that she is, told Kim "at least we have insurance now." Crystal is only 31 years old and Clayton is 26. Even though she continues to face challenge after challenge in life, she has always expressed how grateful she is to know her other two boys placed through AFTH are well taken care of by their adoptive parents. Crystal has told Kim how thankful she is that AFTH continues to be there for her and that she is eternally grateful for everything we have done to offer support, including the much needed gift cards just before the holidays.

These women are not only thanking AFTH, but they are also thanking all the families and adoption supporters who have made donations. Those who have graciously given to the Birthmother Fund or sent in gift cards so that AFTH may delegate those funds to those who need it most.

The financial burdens don't stop just because the holiday season has passed and AFTH's Birthmother Fund continues to need replenishing so we are able to offer help to all those who need it most throughout the year. AFTH Does Outreach to Clients that Adopted Children from Guatemala

In October, at the direction of AFTH Executive Director Maxine Chalker, a letter was mailed to the nearly 500 families that adopted children from Guatemala via AFTH during the years 2000-2009. The purpose of the letter was to remind these families of the need for some of them to complete steps toward finalization of the adoption of their children, establishment of their children's U.S. citizenship, and presentation of evidence of their children's U.S. citizenship to the Social Security Administration

(SSA). The letter emphasized that lack of completing these steps could lead to affected children "encountering difficulties as they become old enough to seek drivers licenses, apply for jobs, file for college loans, enlist in the armed forces, or otherwise seek privileges that can be impacted by a person's familial and/or immigration status."

In response, AFTH received dozens of telephone calls and emails from families wishing to confirm whether there were any additional actions that needed to be taken to ensure their children's rights. From this communication, it was wonderful to confirm that, of the many families that contacted the agency, every one that needed to finalize the adoption of its child in court in the U.S. had already done so. There were, however, a number of families that had not yet attained evidence of their children's U.S. citizenship, and others that had attained such, but had not presented this to the SSA. The agency was glad to be able to remind families of how to complete necessary steps, taking comfort in the knowledge that impacted children would have all the legal protections for which they are eligible.

The many positive and thankful replies received from families are best reflected by one email which read, "Thank you for your recent letter in regard to (my son's) Social Security status. I went to the Social Security office and updated his status immediately. We deeply love (our son). He will be ten years old later this year. He is such a gift. He is doing really well in school and has a good group of buddies. He is very quick witted and he makes us laugh all the time. He loves golf. He does eat too much mac and cheese, but we are working on that. He is also adored by his big brother. They are close and have a beautiful bond. Our life is full thanks to the efforts of your staff. We will forever appreciate."

As stated in the letter sent to Guatemala Program clients, Adoptions From The Heart maintains an "ongoing commitment to, and concern for, our clients and their children." A Letter from Executive Director Maxine Chalker

Dear Friends:

As we begin another year and look forward to all that 2013 will bring, we look back in review of all the success and changes AFTH has seen in 2012.

We were excited to announce over the summer that we have expanded our services and opened our Domestic Adoption Program to couples and singles living anywhere in the United States. Former AFTH families have told us how happy they are to now be able to recommend AFTH's services to their friends and family living outside of our 6 state service area.

Our Domestic Program continues to thrive as we have seen our infant placements rising. In 2012, AFTH placed 187 infants into loving homes which is an increase of 33 placements from our 2011 stats and well above our 160 placement average! Social workers have been working day and night, weekends and holidays to maintain AFTH's reputation for the high quality services and support we offer those considering making an adoption plan as well as the services we offer to adoptive parents.

We are proud to be an agency that has a high percentage of waiting families placed each month. In 2012, AFTH averaged a 16% placement rate of all of the families in the book each month which is fantastic. Some months we have seen a placement rate as high as 22%! AFTH does not have average wait times because we see a variety of situations and placements often depend on the openness of a parent's key. However, as of January 1st only 17% of all of our families in the book ready to be placed have been waiting for more than 1 year. And for those open to children of African-American heritage, only 7 families in our books have been waiting for more than 6 months!

We are continuing to see a high level of emergency placements from hospitals. Hospitals have said they appreciate our social workers' fast response and willingness to be there any time they are needed to help counsel a patient. Additionally, we have seen an increase in hospitals and clinics that have invited us in for staff trainings to talk about the adoption process, what the hospital placement process is like, and to answer any questions from their staff. These trainings have been extremely helpful in opening up the lines of communication with hospital and clinic staffers as well as spread awareness about our agency's services to pregnant women and prospective adoptive parents.

The agency has redesigned our website and, in addition to the learning center for pregnant women and adoptive parents, our new website features sections with tools and resources specifically designed for expecting fathers and family members of those experiencing unplanned pregnancies. In moving to a more digital approach, AFTH has replaced DVD family videos with a Youtube channel which can be accessed to see individual videos. This has eased the process of showing profiles for emergency placements as social workers are now able to log directly into the AFTH network to access both the profile and the video instead of needing to stop at the office for physical hardcopies.

Our social media fan base continues to grow. We can be found on Google+, Facebook, Pinterest, Twitter, and our blog on Wordpress. With close to 1,500 fans, the AFTH Facebook page is a great place to find support as well as helpful resources about adoption. Be sure to join in the discussion and share your experiences with others.

This past holiday season, with the help of donors like yourself, we were able to gift \$11,450 in gift cards to 32 birthmothers and their 68 children. We thank each and every one who made a donation to AFTH this past year in order for us to continue serving those who need it the most, especially during the holidays.

Congratulations to all of the new families created this past year. We look forward to another successful year and thank all the friends who continue to support AFTH's mission.

We also held contests each week in November:



AFTH Clients Offer Advice about Open Adoption to Those Just Beginning the Adoption Process

We asked our Facebook fans to respond to the below question with their advice and suggestions to those at the very beginning of the adoption process. Don't miss out on our discussions, be sure to "like" us on Facebook.

Many of those beginning the adoption process, such as going to an info meeting, are often nervous about the idea of open adoption as it can be a scary idea at first. What is your advice to those just beginning the process? What would you tell them about open adoption or beginning the adoption process in general.

Zarah: As a birthmother, it is very difficult at first. You are very unsure the relationship and where you stand. But as time goes on and I got more comfortable, it is a wonderful blessing. Figure out the amount of openness you would like, and as time grows so does the relationship.

Joni: When my daughter decided to put my grandson up for adoption, I was devastated, but she chose Open Adoption. It's the best decision she ever made in her life. It wasn't the end like I thought. When you do your face to face meeting, make sure you get all your questions on the table and out so there are no questions in your mind when you leave.

Kevin: I would advise that people examine those fears and find common threads with birth families. Are you feeling you won't get picked or that you are being judged by strangers? Birth families might be struggling with those same issues. Are you worried that you will be picked by someone who, as the TV movie scripts go, changes their mind? Birth families have to put a tremendous amount of faith in you, too, and hope that you won't "change your mind" as well. You and your child's birthparents -- because you WILL get picked -- are always going to have one thing in common: All of you will always put your child's needs first. So you might as well find common ground from the get go.

Dina: As far as open adoption: There are so many varying degrees of open adoption. The openness of each situation is really a comfort level between birth family and the adoptive family. It will also change and develop as your child grows.

Mitzki: I would explain that open adoption can mean a LOT of things, from limited contact through an agency to complete openness, to the many places in between. As far as starting the process, educate yourself as best you can, ask questions, and make copies of everything!

Pamela: The cons of open adoption seem to be about the communication and social issues between adoptive and birth parents. While the pros all seem to point to possible benefits to the adoptee and to the overall best interest of the child. You can work through any "cons" if both sets of parents always put the child first.

Erin: We went into adoption with the mindset that we would have a closed adoption. From the first moment that we met our birthmother, we feel in love with her and all of our fears of "open adoption" were gone. It's an incredible feeling to know that when/if our daughter ever has a question about her birth family, we have access to get those questions answered for her by loving people that want nothing more in life than to see her prosper.

Sharon: Fear is a normal part of an open adoption, but the benefits completely outweigh any fears that you may have. Go with an open mind and not be afraid to ask questions, no matter how small or silly you may think it might be.

Cynthia: When my husband and I first heard of open adoption it scared us to death. Would someone come and just knock on our door to see our child? We learned through our info sessions and talking to other adoptive families how unique this journey could be. Two unique journeys and a very huge family now, we wouldn't have it any other way.

Melissa: We looked at "open" adoption as an amazing gift. We often thought about how the birth mother must feel about placing her baby and how scary it is for her... this way she would always know how her baby is doing and growing.

Stephane: My first bit of advice is to meet with couples who have been through the process. Listen to their stories; ask very open and honest questions about their process. The process can be very overwhelming and it's certainly educational. You learn a lot about yourself during this time. It is a very emotional journey but certainly one worth taking.

Barb: I think open adoption is like marriage, when you open your heart to your new child, you get new, bigger families the good the bad and the truly awesome!

Ashley: The birthmother or birthfather that chooses you as the adoptive family will feel the same way. Wondering if they are choosing the right family. Talk to as many adoptive parents as you can and hear all of the fears and joy! The classes are amazing and the information and knowledge you receive is priceless.



Recent Legislation



ADOPTION TAX CREDIT - On January 1, 2013, Congress passed the American Taxpayer Relief Act of 2012 which became law on January 2, 2013, when President Obama signed it into law. The Adoption Tax Credit was one of the provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001 which has now been made permanent. The adoption community had been nervously awaiting the extension of the tax credit and was excited to learn that it was made permanent and not just extended temporarily as expected.

The basic ground rules for the tax credit have remained the same. The IRS has just announced the maximum credit as well as the income limits for eligibility which are adjusted each year in accordance with the cost of living. The maximum credit for 2013 is \$12,970 and the credit begins being phased out for taxpayers with a modified adjusted gross income of \$194,580 and phases out completely at \$234,580. The tax credit will remain flat for special needs adoptions, which means that people who adopt children who are determined to be special needs (or hard to place) by a state or county child welfare agency can claim the maximum credit regardless of their expenses.

The main change to the Adoption Tax Credit for 2013 is that it is no longer a "refundable credit" as it was in 2010 and 2011 which means that the adoptive parents' tax liability will determine the amount of credit able to be applied that particular year. However any unused portion of the tax credit can be carried over for up to five years which will allow the credit to be used in its entirely for most adoptive families. Be sure to talk with your tax preparer about how the Adoption Tax Credit will benefit your family.

UTAH - Utah Supreme Court ruled in favor of a Florida birthfather whose rights were terminated before he was notified that he even had a child. The court found that there was no basis to conclude the father knew or reasonably could have known what occurred. The decision was made to return the child to her father.

MICHIGAN - There are bills before the Michigan House that would permit private adoption agencies with state contracts to reject prospective adoptive parents on any moral or religious basis. This could ultimately undermine a child's best interest and may be a move to prevent lgbt families from adopting.

UN CHILDREN'S RIGHTS PANEL SEEKS TO BAN "BABY BOXES" IN EUROPE - Similar to the Safe Haven laws in the U.S., "Baby Boxes" facilitate anonymous infant abandonment and are available in about 11 European countries. Over the last decade, hundreds of babies have been abandoned this way although limited surveys


European countries. Over the last decade, hundreds of babies have been abandoned this way although limited surveys suggest that it has not reduced the number of infant murders. Committee members note that the boxes undercut children and parent's rights and do not address the causes of abandonment and discourage women from accessing medical care.

WASHINGTON STATE - Pursuant to a law passed this year, Washington State's Department of Social and Health Services is asking 9,000 families who adopted children with special needs to voluntarily reduce the size of their monthly subsidies. The law also reduces the amount families can receive in adoption assistance to 80% of foster care maintenance payments for new contracts as of July 2013. Currently families are able to receive equal amounts.








International Adoption News



In what can only be characterized as a tragedy, on December 28, 2012, Russian President Vladimir Putin signed legislation into Russian Federal Law prohibiting the adoption of Russian children by Unites States

citizens. This law went into effect on January 1, 2013. The sudden ban on intercountry adoption from Russia to the U.S. followed, by a matter of weeks, passage of a U.S. law critical of Russia's human rights record. Although the U.S. legislation was unrelated to issues of child welfare, the closure of adoption from Russia to the U.S. can only be viewed as a retaliatory political maneuver on Russia's part. At present, the U.S. Department of State (USDOS) is urging the Russian government to honor the bilateral adoption agreement between the two nations (which was signed in 2011 and just entered into force on November 1, 2012), at very least to the extent that it permit American families already in the process of adopting a child from Russia to complete their adoptions.

This development is heartbreaking for so many, and foremost for Russia's orphaned children, estimated to number more than 700,000. It clearly delivers the message that Russia's government places political brinkmanship ahead of their wellbeing. Intercountry adoption was never, nor was it ever designed to be, a primary solution for the needs of Russia's child welfare system. As I can professionally and personally attest, however, it did make every difference in the world for the approximately 60,000 children who found love and permanency via this process. Our hearts go out to those relegated to a childhood of institutional care, and to future prospects thereby so terribly compromised.

In news regarding other countries:

Cambodia: Cambodia's Secretary of State for the Ministry of Foreign Affairs announced on October 29, 2012, that Cambodia has agreed to resume adoptions with the United States as of January 1, 2013. The Secretary added that the annual number of such adoptions would not exceed 200. USDOS, however, issued notice on January 2, 2013 that it is unable to process adoptions from Cambodia at this time. Rather, the notice states that Cambodia would first need to further "strengthen its child welfare system and

improve the integrity of its domestic and intercountry adoption processes." As background, there has been a moratorium on adoptions from Cambodia to the U.S. since 2009, and no such adoptions have occurred since 2006.

Haiti: Haiti's new administrative adoption procedures went into effect prior to the end of 2012. At that time Haiti's adoption authority, l'Institut du Bien Etre Social et de Recherches (IBESR), indicated that it would continue to process adoption cases submitted through November of 2012 under pre-existing adoption procedures. The new adoption law centralizes the referral of children for intercountry adoption with IBESR. It further requires that IBESR interview such children's surviving biological parents to obtain their informed pre-consent prior to IBESR determining children's potential eligibility for intercountry adoption. The new procedures prohibit "independent" adoptions, and instead require that all future cases be processed by U.S. adoption service providers (ASP's) licensed by IBESR to perform adoption services in Haiti. The present expectation is that Haiti may license 4 or 5 U.S. ASP's, and that it may issue these licenses in January. Taking a broader view of the plight of Haitian orphans, current estimates are that 50,000 children are residing in Haitian orphanages. The care in many of these is poor, evidenced in the Haitian government's closing of 26 such institutions within the past year due to substandard conditions. And, beyond the aforementioned number of children, it is further estimated that between 250,000 to 500,000 Haitian children are being forced to work as domestic servants, or "restaveks" (Haitian Creole for "stay with"), according to the International Organization for Migration.

India: In order to clear a backlog of cases, as of December 1, 2012, India placed a temporary freeze on its acceptance of new applications from foreign ASP's. India's Central Adoption Resource Authority (CARA) announced at that time that it would continue to process previously registered applications. It is hoped that CARA will resume allowing registration of additional prospective adoptive families as of February of 2013.

Kyrgyzstan: Of the original 65 North American families whose adoption processes were placed into limbo in

2009 when a moratorium on adoptions from Kyrgyzstan went into effect, 16 families continue to pursue the adoption of children referred to them. Of the balance of families, approximately 20 have since experienced the adoption of referred children by Kyrgyz families, 18 have abandoned their adoption process, 9 have brought adoptive children home to the U.S. and, tragically, 2 children have died of illness while remaining under Kyrgyz state care.

In the meantime, the government of Kyrgyzstan continues to experience frequent change, including having had 5 different Prime Ministers since 2009. Further, the Social Development Minister and Assistant Minister, whose office is in charge of accrediting international adoption agencies, were each arrested during the past

summer for, allegedly, accepting bribes. And, as ever, children's homes (ie. orphanages) continue to be overcrowded by the 11,000 orphans (as estimated in 2011 by Radio Free Europe) living in them.

Ukraine: While the number of Ukrainian orphans annually adopted by American families has remained fairly steady over the past decade, the number of such children being domestically adopted by Ukrainian families has increased, including some 1,300 in the first 8 months of 2012. Under current Ukrainian legislation, foreigners are eligible only for the adoption of orphans over the age of 5 and/or those with health difficulties. According to Ukraine's Social Policy Minister, there are approximately 26,000 children waiting for adoption in the Ukrainian database, of which 24,000 are over the age of 5 and/or have special needs.
